Worker Clymer told the board that Summer Worker Austin Schuster was wanting to work again this summer. The board approved, providing he was out of school.

President Hedden thanked the workers for all their help on cleaning the streets with the big snow. Noe stated that the village would not be raking any rocks out of anyone's yard.

Trustee McKinney said that Western Wayne Water District would be purchasing more water from Wayne City in the future. She also stated that Western Wayne was happy with the help from the village and the workers.

Trustee Noe stated that the gas portion of our bills would be more but we do not know how much yet until we receive the next bill from Utility Gas Management.
